

## 2019 WAIVER AND RELEASE OF LIABILITY

I fully understand and acknowledge that:

- (a) risks, dangers exist by reason of the terrain and condition of the Companies property
- (b) risks and dangers exist in my use of airsoft replica weapons and/or other equipment and my participation in Companies activities and at premises of the Property Owner
- (c) my participation in activities at Companies property and/or use of airsoft equipment resulting in my injury or illness including but not limited to bodily injury, disease strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, loss of limb, death or other ailments that could cause serious disability at owner of premises;
- (d) these risks and dangers may be caused by the negligence of the agents, officers, employees, representatives, property owner, the negligence of the participants, the negligence of others, accidents, breeches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and
- (e) by my participation in these activities at Companies property and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence of other conduct of the agents, officers, employees and representatives of the Company, and the owner of the premises, or by any other person.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify the Company and the Property Owners, there agents, officers, employees, representatives, heir, assigns, and previous owners from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise from my activity at the facilities whether caused or contributed to, in whole or in part, by the negligence of the Property Owners, its owners, agents, officers, employees and representatives. I specifically understand that I am releasing, discharging and waiving any claim or cause of action that I may have presently or in the future against the property owner, there agents, officers, employees and representatives arising from my activity at the Companies property.

I fully understand that this activity involve risks of serious bodily injury, including permanent disability, paralysis, and death, which may be caused by own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "release's" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully except and assume all such risks and all responsibility for losses, cost, and damages I might incur as a result of my participation in the activity
